

Hogy Vagy Egyesület FairyTaleGroup - Privacy Policy

Data provided voluntarily by the 'Applicant' on the application form to the FairyTaleGroup programme on the webpage of the Hogy Vagy Egyesület, is processed by Hogy Vagy Egyesület, address: 1028 Budapest, Táncsics Mihály utca 6. (from now on as 'Controller') in accordance with below policy.

The personal data provided by the 'Applicant' during the application is handled in accordance with the Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information and Directive 95/46/EC of the European Parliament and of the Council of 24 October 1995 on the protection of individuals with regard to the processing of personal data and on the free movement of such data.

Legal basis of data processing based on Section 5 § (1) a) of the Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information is the voluntary consent of the data subject. The aim of data processing is communication related to the programme, communication with the applicant, preparation for the programme.

What personal data do we collect?

Child's Name, Child's Date of Birth, Name of Parent, Phone number, E-mail address, Billing address, "Anything else you want us to know about your child. Your questions about your child."

How do we store your data?

The data is stored on the Google Drive of Hogy Vagy Egyesület, is protected and only accessible by group leaders (in a password protected form). The data is not accessible for anyone besides the 'Controller'. The 'Controller' does not give access to 'Applicants' personal data to a third party.

Until when do we store your data?

The 'Controller' retains the 'Applicants' personal data for one year from the time of application, and deletes it afterwards without a warning.

Your rights regarding data

The 'Applicant' can request at any time, that the 'Controller' give an extract of the 'Applicant's' personal data, correct, delete, restrict or temporarily stop processing of personal data. If needed: 'Applicant' can request an extract of the provided personal data in Microsoft Word format, or that the 'Controller' transfers personal data to the 'Applicant' or another service provider.

The 'Applicant' can withdraw consent from the 'Controller' processing data at any time, however this will not affect the legality of data processing prior to withdrawal.

Above listed requests will be fulfilled in 30 calendar days at most, from the day of acknowledgement.

Judicial remedy

In the event of any infringement of their rights, the data subject, may turn to court action against the 'Controller' based on the Act CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information § 22.

The 'Applicant' can initiate an investigation at the National Authority for data Protection and Freedom of Information, in case of a violation or the possibility of violation in the processing of personal or public data.
